To: The residents and property owners of the Township of Ocqueoc, Presque Isle County, Michigan, and any other interested persons.

PLEASE TAKE NOTICE, that at a regular meeting held on June 10, 2010, the Township Board adopted Ordinance #2010-1. The summary of the ordinance appears as follows:

OCQUEOC TOWNSHIP FIREWORKS DISPLAY ORDINANCE #2010-1

Section 1: NAME, PURPOSE AND INTENT. This section sets forth the name, purpose and intent of the Ordinance.

Section 2: APPLICATION AND SITE PLAN. This section sets forth the site plan requirements for a permit under the Ordinance.

Section 3: REQUIREMENTS AND RESTRICTIONS. This section sets forth the requirement for a fireworks display within the Township and the restrictions on the same.

Section 4: ENFORCEMENT. This section set forth the procedure for enforcement of the Ordinance.

Section 5: SEVERABILITY. This section provides that if any portion of the Ordinance is declared invalid such invalidity shall not affect any other portion of this Ordinance.

Section 6: EFFECTIVE DATE. This section establishes the effective date of the Ordinance which shall take effect on the date of its publication after adoption.
