### OCQUEOC TOWNSHIP Summary of Ordinance No. 2014 -1

A Revocable Ordinance granting to Wolverine Power Supply Cooperative, Inc. for a period of 30 years following publication of this Ordinance, approval to acquire, construct, operate and maintain facilities for the production, transmission and sale of electric energy to its member-distribution cooperatives and between Wolverine and other parties.

#### OCQUEOC TOWNSHIP HEREBY ORDAINS:

Section 1, Revocation. The franchise granted herein is revocable by the Ocqueoc Township Board as provided by law.

Section 2, No Damage to Streets or Rights of Way. The Franchisee shall not injure any street, highway and alley, or in any way disturb or interfere with any water, sewer or other utility line.

Section 3, Notification and Approval Prior to Construction. The Franchisee, prior to construction or installing any electric transmission lines or other apparatus, shall notify in writing the appropriate county and/or township authorities. Upon completion of any construction project the Franchisee shall, to the extent reasonably practical, restore the site to its pre-construction condition.

Section 4, Construction Encumbrance. The Franchisee shall not allow any street, highway or alley to remain encumbered by construction for any period longer than is necessary to execute the required work.

Section 5, Insurance and Indemnification. The Franchisee shall furnish Ocqueoc Township proof of insurance, and hold the township harmless from any and all cost incurred by the township because of Franchisee's acts and/or omissions while operating its electric utility business within the township.

Section 6, Legal Compliance. The Franchisee shall comply with all applicable safety requirements, standards and laws, plus all applicable federal, state and local laws and regulations.

Section 7, Zoning Compliance. The Franchisee shall comply with the requirements of Ocqueoc Township and/or Presque Isle County's Zoning Ordinances with respect to any and all of its installations and operations.

Section 8, Assignment. The franchise granted by this ordinance may be assigned by the Franchisee upon written consent of the township.

Section 9, Effective Date. This ordinance takes effect the day following the date of the publication per applicable law.
